CONTINUATION OF ORGANIZATION'S MISSION: COMPREHENSIVE AND COORDINATED INTEGRATED CARE IS IMPORTANT IN ENSURING THAT MEDICAL NEEDS ARE ADDRESSED AS WELL AS WELL AS THE MENTAL HEALTH CONDITION. THE ABBE CENTER BECAME AN INTEGRATED HEALTH HOME PROVIDER FOR MEDICAID RECIPIENTS 6 YEARS AGO IN AN EFFORT TO IMPROVE HEALTH OUTCOMES WITH THESE INDIVIDUALS. MHC SERVED 11,977 INDIVIDUALS IN CY 19, WITH MORE THAN 83% HAVING MEDICARE OR MEDICAID AS THEIR PAYER WITH AN ADDITIONAL 5% BEING FUNDED BY COUNTY TAX DOLLARS.

THE COORDINATION AND INTEGRATION OF PHYSICAL AND MENTAL HEALTH CARE ASSIST BOTH THE INDIVIDUAL AND THE PROVIDERS A MORE COMPREHENSIVE APPROACH TO OVERALL HEALTH OF THE INDIVIDUALS. BY IMPROVING OVERALL HEALTH, INDIVIDUALS WILL REDUCE ACCESS TO HIGHER COST SERVICES, REDUCE OR CONTROL MAJOR HEALTH FACTORS SUCH AS DIABETES AND HEART DISEASE AND LIVE HEALTHIER AND MORE INDEPENDENT LIVES IN THE COMMUNITY.
