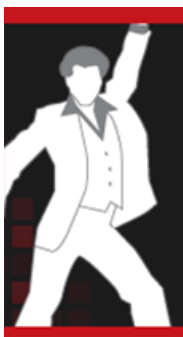
The CTC has a kit with supplies for running your own Hands Only Event. There is no charge for this kit, call and reserve it today! (515-241-6811)

Epi-Pens in Schools

A bill recently signed by Governor Terry Branstad is **SF 462– Epi-Pens in Schools**. The bill allows school districts to have a supply of epinephrine auto-injectors (epi-pens) in each school. Permits healthcare professionals to prescribe epi-pens in the name of the school and also allows certain personnel to administer the epi-pen to a student having an anaphylactic (allergic) reaction. Those who administer the epi-pen have immunity from legal liability. Adds epi-pens to the list of medications that can be self-administered by students with asthma. Allows students with written permission from a health care professional to have their own epi-pens on school grounds. Effective 7/1/2015.

Auvi-Q Talking Epinephrine Autoinjector

It came to my attention that not all instructors are aware of the talking epinephrine pen. Teaching the Auvi-Q pen is not required content in the AHA Heartsaver First Aid course but may be useful for answering questions in the classroom.
