To whom do I make my check?

Make checks payable to UnityPoint Health - Des Moines Foundation. Support for United Way and Variety should be made payable to them.

When is a one-time payroll deduction taken out of my paycheck?

One-time payroll deduction is deducted the first pay period in 2020 - January 10, 2020.

How do payroll deductions work?

Your gift per paycheck can add up to a lot each year. Payroll deductions are made over 26 pay periods starting in 2020. Let's do some number crunching. If you give a little bit... it will add up over time. The following chart can assist you in determining annual gift totals.
