TXOJ CAI: Iowa Kev Kho Mob, d/b/a UnityPoint Health (UPH) Cov Tsev Kho Mob thiab Cov Koom Haum Tsev Kho Mob (Iowa Health System, d/b/a UnityPoint Health (UPH) Hospitals and Hospital Organizations) yuav ua kom tiav lawv lub luag hauj lwm muab kev pab rau sawv daws uas yog muab txoj kev kho mob thaum muaj xwm ceev thiab lwm yam kev kho tus mob uas yuav tsum tau kho rau txhua tus neeg uas tsis hais txog qhov lawv yuav them taus los tsis taus. UPH Cov Tsev Kho Mob thiab Cov Koom Haum Tsev Kho Mob yuav tsum muab kev pab nyiaj txiag rau cov neeg mob uas tsim nyog tau txais kev pab.

CIAM DEJ NUM: Tag Nrho UPH Cov Tsev Kho Mob thiab Cov Koom Haum Tsev Kho Mob (muab sib sau hu ua "Cov Tsev Kho Mob UPH") uas yog raug zam tsis tau them se raws li txoj cai 501(c)(3). Daim Ntawv Teev C, txuas nrog ntawm no, piav txog tej kev pab thiab cov kws kho mob uas koom muaj nyob rau hauv Cov Tsev Kho Mob UPH.

HAUV PAUS NTSIAB LUS: Raws li yog cov koom haum tau txais kev zam tsis them se raws li txoj cai ntawm Internal Revenue Code (IRC) Section 501(c)(3), cov Tsev Kho Mob UPH ua tau raws li cov kev kho mob uas yuav tsum tau kho rau txhua tus neeg mob uas nrhiav kev pab, tsis hais lawv yuav them taus los tsis taus rau cov kev kho mob uas muab rau lawv. Ib yam li ntawd, cov neeg mob muaj lub luag hauj lwm muaj kev tuav pov hwm pab kho mob (insurance) thiab them rau ib feem ntawm lawv cov kev kho mob, thiab cov Tsev Kho Mob UPH muaj lub luag dej num los mus sau qhov nqi kho mob los ntawm cov neeg mob.

Raws li nqe lus Internal Revenue Code Section 501(r), xwv kom nyob tau mus ntxiv raws qhov kev zam tsis tau them se, txhua Lub Tsev Kho Mob UPH yuav tsum tau muaj thiab nthuav qhia nws txoj cai pab nyiaj txiag kom dav rau sawv daws paub.

Lub hom phiaj ntawm txoj cai no yog qhia txog cov teeb meem uas thaum Cov Tsev Kho Mob UPH yuav muab tus nqi txo kom tsawg rau cov neeg mob uas xav tau kev pab txog fab nyiaj txiag.

1. Cov Ntsiab Lus Txhais.

- 1.1 Tsev Kho Mob. Ib qho chaw uas lub xeev kom yuav tsum muaj daim ntawv tso cai, sau npe cia, los yog raug lees paub ib yam li ntawd raws li yog ib lub tsev kho mob. Ntau lub tuam tsev tswj los ntawm ib lub Koom Haum Tsev Kho Mob nyob hauv lub xeev tib daim ntawv tso cai muab xam tau hais tias yog tib Lub Tsev Kho Mob.
- 1.2 Koom Haum Tsev Kho Mob. Ib lub koom haum raug lees paub, los yog nrhiav kev kom tau txais kev lees paub, raws li piav hauv Nqe Lus 501(c)(3) uas tswj ib los yog ntau lub Tsev Kho Mob. Qhov no muaj lwm lub koom haum twg uas

muaj cov luag hauj lwm los yog hom phiaj muab Tsev Kho Mob txoj kev kho mob.

- 1.3 Pob Nyiaj Pom Zoo (Allowed Amounts). Pob nyiaj ntau tshaj plaws them rau cov kev kho mob uas kam them. Qhov no kuj muab hu ua "tsim nyog tau txais cov nyiaj them," "kev them nyiaj pom zoo" los yog "tus nqi khom."
- 1.4 Pob Nyiaj Uas Keev Muab Tsib rau Cov Neeg Mob Uas Muaj Kev Tuav Pov Hwm Them (Amounts Generally Billed to Individuals Who Have Insurance, AGB). Txoj kab ke nram qab no yog cov Tsev Kho Mob muab los siv laij Pob Nyiaj Uas Keev Muab Tsib rau Cov Neeg Mob Uas Muaj Kev Tuav Pov Hwm nyob rau hauv txoj cai no them.

- 1.4.3 Pob Nyiaj AGB tam sim no rau txhua lub Tsev Kho Mob UPH tau muab tso rau ntawm Daim Ntawv Teev B rau tsab cai no. Pob nyiaj AGB yuav raug muab hloov kho txhua lub xyoo.
- 1.5 Kev Kho Mob Uas Yuav Tsum Tau Kho. Cov kev pab kho mob uas (1) raug raws kev kuaj tau thiab kho tus mob ntawm tus neeg mob; (2) raug raws li cov qauv kev cai ntawm txoj kev kho mob tau zoo; (3) tau raws kev nqua hu txog kev kho mob ntawm tus neeg mob thiab muaj chaw txawb chaw rau dua kev yooj yim ntawm tus neeg mob los yog tus muab kev kho mob los yog tus tu saib tu neeg mob; thiab (4) tus nqi kho mob tsawg tshaj plaws uas haum raws li kev kho mob ntawm tus neeg mob.
- 1.6 Kev Kho Mob Thaum Muaj Xwm Ceev. Raws li tau piav nyob rau hauv Tsab Cai Lij Choj Muab Kev Kho Mob Thaum Muaj Xwm Ceev thiab Kev Ua Hauj Lwm (Emergency Medical Treatment and Labor Act) ("EMTALA"), ib tus mob uas qhia txog cov tsos mob hnyav uas yog hais tias tsis tau txais kev kho tus mob yuav ua rau txoj kev noj qab haus huv ntawm tus neeg mob ntsib teeb meem hnyav tshaj tuaj, ua rau kev ua hauj lwm ntawm lub cev muaj teeb meem, los yog muaj teeb meem txog ib yam khoom hauv nruab nrog cev ua tsis tau hauj lwm. Ib tus poj niam cev xeeb tub uas mob plab yuav yug tus me nyuam.

- 1.7 Tus (Cov) Neeg Mob. Nrog rau tus neeg mob thiab/los yog tus neeg mob tus neeg muaj lub luag hauj lwm pab nws (niam txiv, tus neeg saib xyuas, tus sawv cev lav).
- 1.8 FINA-Neeg Mob Tsim Nyog Tau Txais Kev Pab. Cov neeg mob uas ua raws cov kab kev piav nyob rau hauv txoj cai no thiab raug txiav txim tias tsim nyog tau txais kev pab nyiaj nyob hauv txoj cai no.

2. Kev Tsim Nyog Tau Txais Kev Pab Nyiaj.

- 2.1 Kev pab nyiaj tsuas muaj rau cov Kev Kho Mob Uas Yuav Tsum Tau Kho thiab Kev Kho Mob Thaum Muaj Xwm Ceev rau cov Neeg Mob Uas Tsim Nyog Tau Txais FINA nkaus xwb. Kev pab nyiaj yuav tsum raug saib raws cov lus qhia nram qab no, tshwj yam cuam tshuam rau kev cai lij choj hauv lub xeev uas yuav tau saib ua qhov tseem ceeb ua ntej raws li muab piav muaj hauv Daim Ntawv Teev A uas muab txuas nrog txoj cai no.
- 2.2 Cov Neeg Mob FINA-Tsim Nyog Tau Txais Kev Pab uas poob qis tshaj 600% nawm Cov Lus Qhia txog Pob Nyiaj Khwv Tau Los Ntawm Cov Neeg Tseem Txom Nyem Hauv Teb Chaws (Federal Poverty Income Guidelines, FPIG) tej zaum yuav Tsim Nyog Tau Txais FINA. Cov Neeg Mob Tsim Nyog Tau Txais FINA yuav tsis kom them ntau tshaj Pob Nyiaj Keev Muab Tsib rau Cov Neeg Mob uas muaj kev tuav pov hwm them.
- 2.3 Tsev kho mob cov ntawv sau nyiaj kom them nqi yuav raug txo rau cov neeg mob hauv txhua cov ntsiab lus FPIG hauv qab no:

- 2.4 Tsev neeg pob nyiaj khwv tau los yuav raug muab los txiav txim seb ib Tug Neeg Mob puas tsim nyog tau txhais kev pab. Tsev neeg pob nyiaj khwv tau los muaj xws li tab sis tsis yog tas rau qhov hauv qab no: Txij nkawm niam txiv sib yuav raws kev cai, cov me nyuam (roj ntsha yug los, los nrog niam los yog txiv, los sis me nyuam saws los tu) thiab khub niam txiv nyob ua ke. (Txij nkawm los yog khub niam txiv nyob ua ke uas koom sib pab them nqi, tsis hais yuav yog tib hom poj niam los yog txiv neej los yog txiv neej/poj niam.)

- 2.5 Ntxiv rau ntawm tsev neeg pob nyiaj khwv tau los, lub Tsev Kho Mob yuav saib ntxiv seb tus Neeg Mob tsev neeg puas muaj khoom vaj tsev muaj nqis uas muab siv tau los mus them nws tej nuj nqis. Cov khoom vaj tsev muaj nqis kuj muaj xws li, tab sis tsis tsis yog tas rau, nyiaj ntsuab, av khauj nyiaj khaws cia thiab nyiaj tshv, daim ntawv pov thawj pob nyiaj, stocks thiab bonds, tus kheej li cov av khauj so noj nyiaj laus (individual retirement accounts, IRAs), trust funds, tej vaj tse (tsis xam tus Neeg Mob lub tsev nyob) thiab tshv. Lub Tsev Kho Mob kuj yuav saib tej nuj nqis uas nyob rau kev ris lub nra ntawm Tus Neeg Mob tsev neeg thiab.
- 2.6 Ntaub ntawv los ntawm Tus Neeg Mob (los yog tub koom xeeb ntawm Tus Neeg Mob Tsev Neeg) ua ntej cov ntawv ua thov kev pab nyiaj tej zaum yuav raug siv los txiav txim rau kev pab tam sim no. UPH kuj tseem yuav siv cov koom haum tus neeg thib peb los pab rau cov kev sau nqi. Yog cov koom haum ntawd muab ib daim ntawv muaj cov ntsiab lus rau UPH hais txog Tus Neeg Mob li qib FPIG, UPH yuav siv tej ntaub ntawv ntawd los txiav txim kev Tsim Nyog Tau Txais FINA thiab them txo nqi uas muaj.
- 2.7 Kev Tsim Nyog Khwv Yees Tau Txais Kev Pab. Cov Neeg Mob uas muaj raws li kev tsim nyog khwv yees tau txais kev pab raws Nqes Lus no tej zaum yuav tau txais kev pab nyiaj yam tsis tas ua daim ntawv thov kev pab nyiaj. Cov ntaub ntawv txhawb kev tsim nyog tau txais kev pab ntawm tus Neeg Mob rau los yog kev koom nyob hauv ib lub txheej txheem kev pab cuam muab teev muaj npe hauv qab no ntawm 2.7.1 yuav tsum tau txais thiab muab khaws cia rau hauv cov ntaub ntawv. Cov ntaub ntawv tej zaum kuj muaj xws li tsoom fwv ib daim npav los yog lwm yam ntaub ntawv teev kev tsim nyog tau txais kev pab los yog muaj feem tau txais kev pab raws cai, los yog luam nplooj ntawv web teev tus Neeg Mob li kev tsim nyog tau txais kev pab. Tshwj muaj lwm yam qhia paub, ib tus Neeg Mob uas khwv yees tias tsim nyog txais kev pab raws kev khwv yees ntaus nqi cov cai yuav tsim nyog tau txais kev pab mus rau lub hlis txuas ntxiv tom qab hnuv pom zoo xub thawj, tshwj lub Tsev Kho Mob tus neeg ua hauj lwm pom tau tias tus Neeg Mob tsis muaj raws li qhov kev tsim nyog khwv yees tau txais kev pab mus ntxiv lawm.
- 2.7.1 Cov Neeg Mob uas tsim nyog tau txais kev pab thiab tau txais kev pab los ntawm cov txheej txheem kev pab cuam hauv qab no tej zaum yuav tsim nyog khwv yees tau txais kev pab nyiaj 100%.
- 2.7.1.1 U.S. Department of Agriculture Food and Nutrition Service
Food Stamp Program.

- 2.7.1.2 Kev tsim nyog tau txais kev pab muaj ciaj ciam - Cov neeg txhaum cai tsis muaj ntaub ntawv nyob hauv lub teb chaws/ 3-hnub sij hawm thaum muaj xwm ceev. Iowa Department of Human Services tso cai them nqi kho mob hauv peb hnub ntawm cov kev pab Kho Mob Medicaid los them rau cov kev kho mob xwm kub ceev ntawm cov neeg uas tsis muaj ntaub ntawv yog pej xeem, neeg txawv teb chaws, los yog tus lej social security uas yuav tsum tau muaj. Cov kev kho mob thaum muaj xwm ceev yuav tsum yog muab hauv ib lub Tsev Kho Mob uas tuaj yeem kho tu saib tus mob tau tom qab tus mob ceev tshwm sim. Kev tsim nyog khwv yees tau txais kev pab rau hom no yuav siv tau hauv 6 lub hlis txij hnub tshwm sim qhov xwm kub ceev.
- 2.7.1.3 Txheej txheem kev pab cuam Medicaid (tsis suav cov lock-in thiab/los yog spend-down)
- 2.7.1.4 Women, Infants, and Children (WIC) qhov kev pab khoom noj

3. Kev Sib Txuas Lus Kom Paub Txog Kev Pab Nyiaj.

- 3.1 Txhua Lub Tsev Kho Mob yuav txuas lus txog kev pab nyiaj uas muaj rau txhua tus Neeg Mob thiab nyob rau hauv lub zej zog. Cov ntawv luam txoj cai kev pab nyiaj (Txoj Cai 1.BR.34), daim ntawv ua thov kev pab nyiaj thiab Daim Ntawv Ntsiab Lus Nkag Siab Yooj Yim yuav muaj xa tuaj tau, muaj nyob rau ntawm txhua Lub Tsev Kho Mob lub website, thiab ntawm cov neeg hauv txhua lub Tsev Kho Mob.
- 3.2 UPH Qhov Chaw Ua Num Central Billing Office muaj teb cov lus nug txog txoj cai nyob rau ntawm tus xov tooj (888) 343-4165, los yog cov Neeg Kho Mob yuav tau mus cuag qhov chaw ua num sau nqi ntawm lub Tsev Kho Mob kom tau cov ntaub ntawv no.
- 3.3 Cov Tsev Kho Mob UPH yuav tsim ib Daim Ntawv Ntsiab Lus Nkag Siab Yooj Yim ntawm txoj cai no.
 - 3.3.1 Daim Ntawv Ntsiab Lus Nkag Siab Yooj Yim yuav xa tau hauv tsev xa ntawv, muaj nyob rau ntawm txhua Lub Tsev Kho Mob lub website, thiab nrog cov neeg ntawm txhua lub Tsev Kho Mob.
 - 3.3.2 Daim Ntawv Ntsiab Lus Nkag Siab Yooj Yim yuav muab rau sawv daws raws li ib feem ntawm cov ntaub ntawv sau tus Neeg Mob npe thiab/los yog tso tawm mus tsev tus txheej txheem.

3.3.3 Daim Ntawv Ntsiab Lus Nkag Siab Yooj Yim yuav tsum muab tso nrog thaum xa daim ntawv ceeb toom rau tus Neeg Mob tias muaj kev Nqis Tes Sau Nqis Loj tawm tsam nws. Txoj Cai UPH 1.BR.40, Kev Tsib thiab Sau Nqi, muaj cov ntsiab lus hais ntiv txog cov kev nqis tes tsib thiab sau nqi, thiab tej zaum mus nqa tau nyob rau ntawm txhua lub Tsev Kho Mob thiab nyob rau ntawm txhua lub Tsev Kho Mob lub website.

3.4 Txoj cai pab nyiaj no, Daim Ntawv Ntsiab Lus Nkag Siab Yooj Yim, thiab tag nrho cov ntaub ntawv thov kev pab yuav tsum muaj sau ua lus Askiv thiab ua lwm hom lus thaum muaj cov neeg paub lus Askiv tsis zoo (limited English proficiency, LEP) tsawg dua ntawm 1,000 leej neeg los yog ntau dua 5% ntawm lub zej zog uas lub Tsev Kho Mob muab kev pab kho mob. Cov ntaub ntawv uas tau muab txhais ua lwm hom lus no muaj xa tau tuaj hauv tsev xa ntawv, muaj nyob rau ntawm txhua lub Tsev Kho Mob lub website, thiab tus neeg nyob hauv Tsev Kho Mob.

3.5 Cov ntawv ceeb toom thiab ntaub ntawv no tej zaum kuj yuav muab raws tshuab fais fab (electronically).

4. Kab Ke Ua Ntawv Thov Kev Pab Nyiaj.

4.1 Neeg Mob Thov Kev Pab Tuav Pov Hwm los yog Nrhiav Kev Ris Lub Nra Ntawm Tus Neeg Thib Peb. Xwv kom tau txais kev txiav txim rau kev pab nyiaj txiag, tus Neeg Mob kuj yuav tsum muab tej ntaub ntawv qhia txog lwm qhov chaw pab nyiaj txiag uas tej zaum yuav muaj them tau tus Neeg Mob tej nqi kho mob, xws li Kev Pab Kho Mob Medicaid, Medicare, tus neeg thib peb them nuj nqi, thiab lwm yam. Cov neeg mob uas tseem muaj kev tuav pov hwm uas tsis yog nyob rau hauv UPH pab pawg kws kho mob yuav tau thov nkag rau hauv pab pawg ua ntej thov kev pab nyiaj txiag.

4.1.1 Txoj cai no tsis siv rau cov feem kev pab rau ib tus Neeg Mob uas tau, los yog tej zaum yuav, them rau los ntawm tus neeg them xub thawj los yog tus thib peb xws li ib lub tuam txhab tuav pov hwm tsheb los yog kev tuav pov hwm raug mob ntawm neeg ua hauj lwm. Raws li tau tso cai los ntawm lub Xeev Iowa, Illinois, thiab Wisconsin, thaum ib tus Neeg Mob tuaj kom muab kev pab tom qab muaj ib qhov xwm txheej ua yuam kev los yog raug mob, tej zaum Lub Tsev Kho Mob yuav muab tsev kho mob ib daim ntawv raws cai mus tuav (lien) tus thib peb tej nyiaj them tuaj.

- 4.2 Tus Neeg Mob Yuav Tsum Ua Daim Ntawv Thov Pab Nyiaj Kom Tiav. Kom tau txais kev txiav txim rau kev pab nyiaj txiag, tus Neeg Mob yuav tsum muab ib daim ntawv thov pab nyiaj uas ua tiav txhij txhua nrog rau tej ntaub ntawv txhawb uas yuav tsum tau muaj rau lub Tsev Kho Mob. Daim ntawv thov yuav tsum muab ua kom tiav siv cov ntaub ntawv ua lus sau, lus hais, los yog siv ob yam ua ke.
- 4.3 Ceeb Toom Rau Tus Neeg Mob Paub Txog Qhov Tsim Nyog Tau Txais Kev Pab. Tom qab tau txais tus Neeg Mob tej ntaub ntawv fab nyiaj txiag, lub Tsev Kho Mob yuav ceeb toom rau tus Neeg Mob paub txog kev txiav txim rau nws qhov tsim nyog tau txais kev pab nyob rau hauv lub sij hawm tsim nyog.
- 4.3.1 Yog tus Neeg Mob tsis muaj feem tsim nyog tau txais kev pab nyiaj thawj zaug, tus Neeg Mob yuav rov qab thov dua tau yog muaj kev hloov pauv nyob rau hauv pob nyiaj khwv tau los, khoom muaj nqis, los yog cov kev ris lub nra ntawm tsev neeg.
- 4.3.2 Ib tus Neeg Mob uas tsim nyog tau txais kev pab yuav tsum koom tes nrog lub Tsev Kho Mob los mus tsim tsa ib daim phiaj xwm them nqi kom tsim nyog uas hais mus txog rau pob nyiaj khwv tau los thiab tej khoom muaj nqis, pob nyiaj muab txo ntawm daim (cov) ntawv tsib nqi, thiab cov nqi them ua ntej.
- 4.3.2.1 Ib tus Neeg Mob uas tsim nyog tau txais kev pab nyiaj yuav tsum muaj lub siab dawb paug them cov nuj nqi kom raws li cov phiaj xwm them nyiaj. Tus Neeg Mob muaj lub luag hauj lwm qhia paub txog ib yam kev hloov pauv twg ntawm nws tej nyiaj txiag uas tej zaum yuav cuam tshuam rau nws rab peev xwm los mus them cov nqi kho mob uas muab txo qis los yog los mus them cov nuj nqis kom raws li cov phiaj xwm them nyiaj.

Tsev Kho Mob Txoj Cai Lij Choj Txo Nqi Rau Cov Neeg Mob Tsis Muaj Kev Tuav Pov Hwm*: Nyob hauv Illinois, Tsev Kho Mob Txoj Cai Lij Choj Txo Nqi Rau Cov Neeg Mob Tsis Muaj Kev Tuav Pov Hwm nqua hu kom txhua lub tsev kho mob txo tus nqi rau cov neeg mob hauv Illinois uas tsis muaj kev tuav pov hwm kho mob (uninsured) uas muaj raws li qeev cov cai tsim nyog tau txais kev pab.

Raws li txoj cai lij choj, cov neeg mob uas tsev neeg pob nyiaj khwv tau los siab txog 200% ntawm FPL nyob rau hauv nroog thiab 125% nyob rau tom hauv sab (los yog nyob rau tej qhov chaw siv tsev kho mob tsis yooj yim) yuav tau txais 100% txo tus nqi. Cov neeg mob uas tsev neeg pob nyiaj khwv tau los nyob nruab nrab ntawm 201-600% ntawm FPL nyob hauv nroog thiab 126-300% ntawm FPL nyob rau tom hauv sab (los yog nyob rau tej qhov chaw siv tsev kho mob tsis yooj yim) yuav tau txais 135% ntawm tsev kho mob tus nqi. Tsab kev cai lij choj tseem muaj pob nyiaj tsib sau siab tshaj plaws txog 25% ntawm tsev neeg cov nyiaj khwv tau los txhua xyoo rau cov neeg uas muaj raws li kev muaj feem tau txais kev pab cov cai thiab tsis muaj khoom vaj tse muaj nqis.

Cov kev txo nqi no tsuas yog siv rau cov kev kho mob tsim nyog yuav tsum tau kho uas yuav them los ntawm Medicare xwb; nws tsis siv rau kev phais kom zoo nkauj los sis tsis yog kho mob xws li kev pab neeg thiab kev kawm kom tau hauj lwm ua. Qhov txo tus nqi no tsis siv rau cov kev pab cuam ntawm kws kho mob.
