

# Medicare Skilled Nursing Facility (SNF) Benefit Enhancement Waiver



January 12, 2021

Your primary care physician and our hospital have chosen to participate in UnityPoint Accountable Care (UAC). UAC is a Medicare Next Generation Model Accountable Care Organization.

Because of this, you are able to receive Medicare-covered services at an approved skilled nursing facility without a hospital stay that crosses three midnights (a 3-day stay). Only the specific skilled nursing facilities listed below meet the Medicare requirements for this program.

*NOTE: If the skilled nursing facility where you wish to receive care is not listed on this card, you may be able to choose another facility if your hospital stay meets the requirements established by Medicare. Your physician will determine if your medical condition requires a hospital stay that crosses three midnights. In order for your skilled nursing care to be covered by Medicare, your hospitalization must meet this requirement.
