## 2013-2014 KINDERGARTEN ENROLLMENT

### ENROLLMENT

**Enrollment time is here!** Now is your opportunity to officially enroll your child in the Kindergarten program at Methodist Family Child Care Center (MFCCC).

**Open House will be Tuesday, February 12, 2013 from 2:30-5:30.**  
Feel free to contact us if you have questions or wish to visit the classroom at another time. Handbooks will also be available.

Parents interested in securing a place for their child in the MFCCC 2013-2014 Kindergarten class needs to do the following:

1. **Sign** the attached agreement. For MMCI employees, \$129 (in no more than \$32.25 increments per pay period) will be deducted from your paycheck starting April 5, 2013. **For non-Methodist employees, submit \$144.00** along with this application as "promise money" for your child's enrollment. The "promise money" will be applied to your child's first week of Kindergarten in the fall. This money is not refundable if your child, for whatever reason, does not become a member of the class.
2. **Submit** a copy of the **child's birth certificate** to the Child Care office. One may be on file.
3. **Submit** the attached enrollment form to the Child Care office.
4. If, during the coming months, you decide that your child will not attend the Kindergarten thus forfeiting the "promise money", promptly **send a letter** containing that information to the Child Care office.

***\*\*Please note ~ Kindergarten expenses are not eligible for reimbursement from most spending accounts. For more information please call your employer's benefits Director. MMCI employees may call Karen Brooks at 672-5777.***

<b>Class Size</b>	12 students maximum	18-25 students on average; sometimes more
<b>One-on-one instruction</b>	Yes. The small class size and quality education enables students to begin their educational career with a solid foundation of support and encouragement, while participating in challenging opportunities to expand knowledge beyond the basics.	Difficult to do with larger class sizes.
<b>Book Fees</b>	\$75 per year	\$75-\$200 per year
<b>Activity Fees</b>	\$0-\$20 per year	\$50-\$150 per year
<b>On site latchkey</b>	Yes. Our latchkey is staffed with high quality teachers that exceed the DCFS standards for educational background.  Children are never bussed to another location for care.
